

GOLD ROAD NAMED DIGGERS & DEALERS' DEALER OF 2017

Well-funded exploration and development company, Gold Road Resources Ltd (**Gold Road** or the **Company**) was last night named Dealer of the Year at the Diggers & Dealers mining forum in Kalgoorlie-Boulder.

The prestigious award recognises the decision by Gold Road to partner with Gold Fields (JSE: GFI, NYSE: GFI) to become a 50% joint venture partner in the world-class Gruyere Gold Project.
